Outline of the Amendment Details of Act on Support for Persons with Developmental Disabilities (1)

Purpose and Basic Ideology (Article 1, Article 2-2)

oTo do an early detection of developmental disabilities and offer developmental support [To enable carrying out daily life and social life worthy o dignity, as an individual] (new), to clarify the duties of national and local public entities regarding [provision of a seamless support] (new).

oTo aim provide support for livelihood as a whole that would enable independence and social participation of developmentally disabled persons, [without discrimination due to presence or absence of disability (elimination of social barriers)] (new), [to respect each other's personality and individuality (consideration to support in decision making) while contributing to a symbiotic society.] (new)

Definition (Article 2)

Persons with developmental disabilities can be defined as those who have developmental disabilities (disorder of the cerebral function such as Attention Deficit/Hyperactivity Disorder, Autism, Asperger's syndrome and other pervasive developmental disorders, learning disability, etc. and a disability that is normally discovered at a young age), and are restricted in their daily lives and social lives due to [due to social barriers] (new) and developmental disabilities

Citizens, employers, etc.

- oThe citizens shall strive to deepen their understanding about [individual development disabilitycharacteristics] (new), etc., and cooperate for the independence and social participation of developmentally disabled persons. (Citizens' duties Article 4)
- o [The employers shall strive to stabilize the employment of persons with developmental disabilities by properly evaluating their abilities and ensuring appropriate employment opportunities as well as a proper employment management according to the characteristics of each individual with developmental disabilities.](new) (support for employment Article 10)
- oThe universities and colleges of technology shall consider appropriate education according to [characteristics of each individual with developmental disabilities] (new) (Education Article 8)





(Remarks) Terms that may be used with regard to developmental disabilities


- Strong behavioural disorder: A situation that requires special support due to intense self injury or other harm.
 High functioning disorder: Not accompanied with intellectual disorders.

- -Autism Spectrum Disorder (ASD): Almost synonymous with Pervasive Developmental Disorder (PDD).

 -Uneven development: In cases with difference in developmental state and ability, but no display of social maladjustment, this representation is used without using the words "disability" or "developmental disability"
