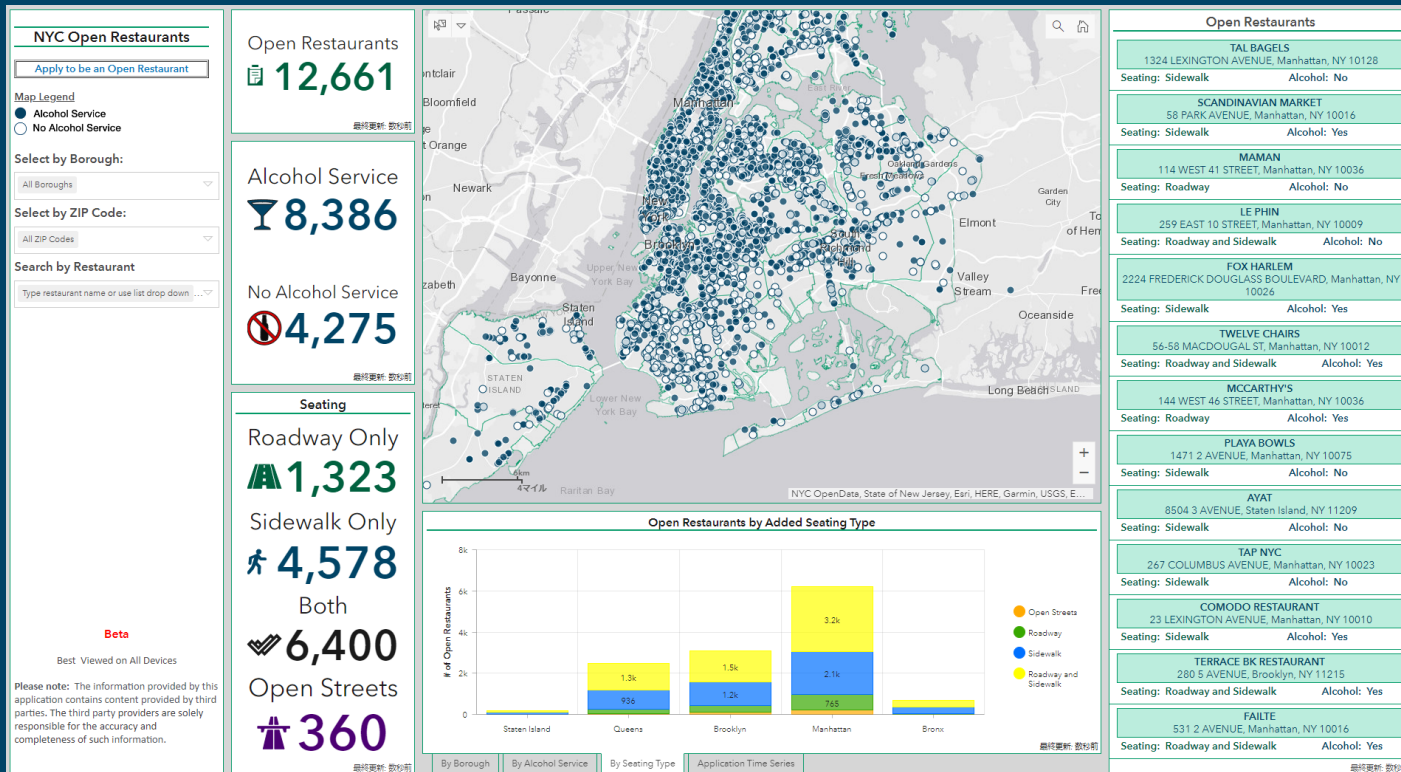


NYC Open Restaurants Program

NYC Open Restaurants Program

▶ オンライン

オンラインで手続きが可能。

▶ ワンストップ

道路占用許可、道路使用許可、保健所の許可を一括で申請できる。

▶ 届出制

許可制ではなく届出制となっているため、申請後すぐに占用可能。

苦情があった場合や点検時に問題があった場合に改善指示。（従わない場合は罰金）

▶ 恒久化

当初は2020年10月末までの予定だったが、恒久化を決定。

（2020/9/25 デブラシオ市長が決定）

▶ 無料

道路占用料は無料

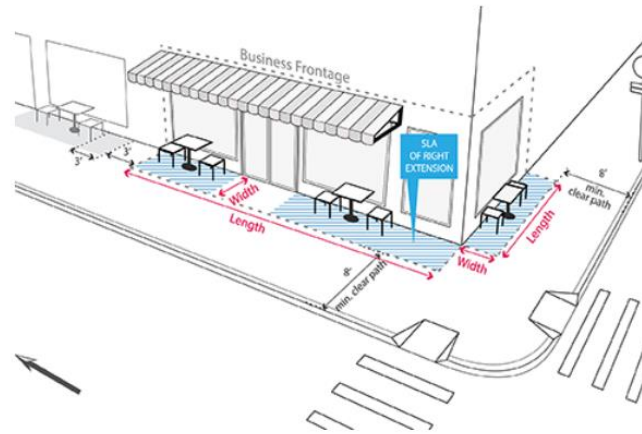

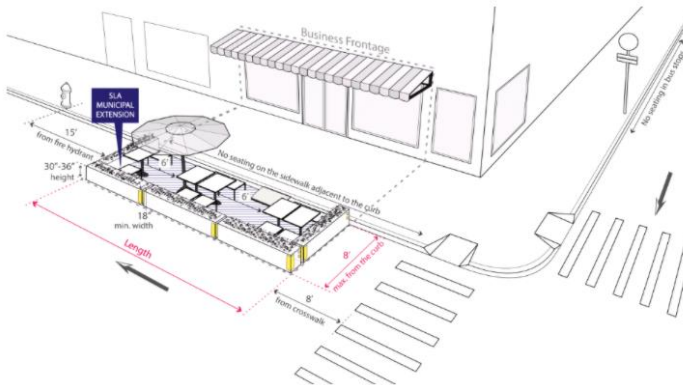
