1 Examination of OMA Decisions

The Market Access Ombudsman Council will conduct an <u>examination of the Office of Market Access decisions taken in the "Comprehensive Review of OTO Cases" and the "FY 2001 Problem Raising Process"</u> in order to confirm whether expected outcomes are being achieved steadily, and whether the grievances are finally solved.

(Specific Methods)

The MAOC Experts Conference will consider progress on OMA decisions from the viewpoints of whether measures have been taken on schedule and whether expected outcomes have been achieved steadily. Complainants may be invited to the MAOC Experts Conference to present their opinions, if necessary.

"Conclusion - Importance of Repeated Review" (Excerpts)

The important thing is to ensure that success is achieved. In other words, cases must be followed through to the final stage, until the complaints are resolved. In order to do so, the MAOC will continue its efforts to review "whether necessary actions are being made," "whether the actions have reached the implementation stage" and "whether the implemented measures are achieving success." In case expected outcomes are not being achieved due to insufficient measures or to slow actions, the MAOC will aggressively prompt relevant agencies to achieve the goals at the earliest possible time.
