Basic Act for Persons with Disabilities (Overview)

Chapter I General Provisions

1. Purpose

Realization of a society of coexistence (cohesive society) with mutual respect for personality and individuality of all citizens, regardless of whether or not they have a disability

2. Definitions

Persons with a	A person with a disability (physical, intellectual, mental (including developmental), and others) affecting the functions of the body or mind, and who are <u>in a state of facing substantial limitations in</u>
Disability	their continuous daily life or social life because of a disability or a social barrier.

Social barriers that stand as obstacles against persons with disabilities engaging in daily life or social life (items, institutions, practices, ideas, and other things in society)

Defined based on concept of "social model" adopted by the CRPD.

The concept that limitation faced by persons with disabilities in their daily and social lives are not caused only by their physical/mental functional disabilities, but by various social barriers

Also provides responsibilities of the national and local governments and people in Japan, the Week of Persons with Disabilities (Dec 3rd to 9th every year), and the White Paper on Persons with Disabilities

Chapter II to III Individual Provisions

Medical Care, Nursing Care

Medial expenses allowance, nursing care, living support

Development of welfare devices, training of assistant dogs

Secure Housing

Securing housing for persons with disabilities

Promotion of housing appropriate for person with disabilities

Development of Cultural Ordinations

Improvement of culture, art, and sports facilities, and subsidization to relevant activities

Education

Improvement of education based on specifics of disabilities

Securing human resources, improvement of educational environment

Access to Public Facilities

Systematic promotion of accessibility

Accommodation for persons with disabilities with assistant dogs

Disaster Prevention and Crime Prevention

Disaster prevention and crime prevention measures according to gender, age, condition of disabilities and ways of living

Also provides matters on pension, medical care and childcare, work consultation, consumer protection, international cooperation and prevention of injuries and diseases which cause disabilities

Promotion of Employment

Securing employment opportunities, stabilizing employment

Alleviation of economic burden in employing persons with disabilities

Access to Information

Promulgation of easy-to-use broadcasting and communications

Prompt and appropriate information communication at the time of disasters

Accommodation in Election, etc.

Improvement of education for smooth voting

Securing means of communication in legal procedures

Chapter IV Commission on Policy for Persons with Disabilities

1. Mission

Studying and delivering, as well as offering opinions concerning formulation of the Basic Programme for Persons with Disabilities

Monitoring implementation status of the Basic Programme for Persons with Disabilities

Possible to make recommendations to relevant ministers, if deemed necessary

Offering opinions concerning the basic policy for the Act for Eliminating Discrimination against Persons with Disabilities

2. Structure

Members are appointed by Prime Minister among persons with disabilities, persons engaged in programs for independence and social participation of persons with disabilities, and academic experts (max 30 persons)

Panels, such as councils, are established also in prefectures (possibly also in municipalities)
