# 1 Purpose

The recent rapid progress of space development and utilization and the accompanying increase in the number of space debris in outer space have raised the risk of collisions between space objects such as satellites and space debris, and they have been attracting attention as an international issue that should be called the environmental problem of outer space as they may hinder the sustainable and stable utilization of space in the long run. For this reason, international discussions are rapidly progressing toward rule-making and normbuilding regarding space traffic management, with a focus on space debris control and the use of earth orbit in outer space.

In view of this situation, and in light of the trends in international discussions and Japan's response, we are convening the "Inter-Agency Task Force on Space Traffic Management" consisting of relevant ministries and an agency, with the aim of promoting close cooperation and effective action by the relevant ministries and agency

### 2 Missions

- (a) To collect and share domestic and international information on space traffic management
- (b) To assess the progress of efforts and address issues related to space traffic management
- (c) To study measures to promote effective efforts regarding space traffic management and more

## 3 Organization

The Task Force consists of a Ministerial Meeting, an Executive Committee and Working Groups.

#### 3.2. Executive Committee

For flexible operation of the Task Force, the Executive Committee, chaired by the Director-General of the National Space Policy Secretariat of the Cabinet Office may be convened under the Ministerial Meeting.

The Executive Committee Meeting shall be convened by the Director-General of the National Space Policy Secretariat of the Cabinet Office and its members shall be as follows. However, when deemed necessary by a majority of the members, the attendance of other relevant ministries and agencies, private sector operators, etc. may be requested.

#### 3.3 Working Groups

Working groups may be convened under the Executive Committee as necessary when the Director-General of the National Space Policy Secretariat of the Cabinet Office deems it particularly necessary in considering measures to promote effective space traffic management efforts.

### 4 Administration

General affairs of the Task Force shall be handled by the National Space Policy Secretariat of the Cabinet Office, with the cooperation of relevant ministries and agencies.

#### 5 Other Matters

In addition to what is provided in the preceding paragraphs, matters related to the operation of the Task Force and other necessary matters shall be determined by the Chairperson of the Ministerial Meeting.
