1. Outline of the SWY (New program)

SWY (New program) is a leadership training program organized by the Cabinet Office, Government of Japan (CAO) which accommodates approximately 230 youths (Age range: 18 to 30 in principle) from 14 countries including Japan (1 or 2 countries each from Africa, Europe, Asia and Middle East, Central and South America and Oceania regions). Participating Youth (PY)of the program will participate in the online exchange in November, 2023, and will gather in Japan to participate in the face-to-face exchange from January to February, 2024. Having participants from every corner of the world, this unique intercultural program aims to develop their leadership skills and encourage them to contribute to the betterment of the world.

The program offers various activities such as Course Discussion, participants-led workshops, cultural exchange events and visits to related institutions and local prefectures in Japan, which strengthen human networks beyond national borders and cultivate cross cultural communication skills.

One of the features of this new program is that the PYs will plan projects to solve social issues related to the SDGs in the region in cooperation with people who are actually working on them onsite and implement the projects they have planned in the local practical program at the final port of call. Preparation for the local practical program will begin from the online exchange and will continue throughout the program. Course Discussions will be conducted in conjunction with this local practical program.

The program recruits 10 Facilitators who take charge of Course Discussion, the academic learning activity. We are looking forward to your application.

2. What is Course Discussion?

During the program, PYs will be divided into 10 topic groups under 5 themes and work on different academic discussion topics related to the local practical program to be conducted in Kochi Prefecture, the final port of call.

The Course Discussion is a discussion program conducted under the guidance of a Facilitator where approximately 230 multinational PYs are divided into groups by topic based on their choice. One group consists of approximately 20 PYs. The flow of the program is as stated in below items from A to F.

- A Basically, Facilitators shall provide PYs with relevant information on the SDGs from a global perspective and encourage them to think about the SDGs through discussions for the smooth implementation of local practical program in Kochi Prefecture.
- B Online Introductory Sessions on weekends are implemented in November, 2023.
- C The session will continue in Japan in January and February of the following year with face-to-face exchanges consisting of onshore activity and onboard activity.
- D During the program in Tokyo and local visit program in the first port of call, Kyoto Prefecture, and the second port of call, Hyogo Prefecture, PYs will deepen their discussion through visits to related facilities and exchanges with people engaged in related activities in line with the theme of the discussion.
- E In Kochi Prefecture, the final port of call, PYs will be engaged in local practical program, making use of what they have learned in the Course Discussions so far. The local people will lead the practical program for each related theme, and Facilitators will join them and observe their activities.

A summary presentation of the local practical program is scheduled under the leadership of Kochi Prefecture on the last day of the port of call (Feb. 17).

F In the final session (Summary Forum) on February 20, PYs will summarize what they have learned from all programs including online programs, programs in Tokyo, onboard activities and port of call activities, and present their findings.

The flow stated in the above items from A to F would be a series of programs (online program duration will be approximately 2 hours per session and face-to-face program duration is scheduled to be for 29 days).

Through the lens of Course Discussion, PYs will deepen their understanding on actual circumstances of respective themes and find solutions in the local practical program. Course Discussion also aims that PYs to acquire the abilities to communicate in a group of people from different cultural backgrounds, and promote mutual understanding through open and vigorous exchange of opinions.

3. Course Themes

Course Discussion will be conducted on the similar themes/topics of the local practical program since it will closely relate to the local practical program that will be implemented under the common theme of "Let's solve issues in community development where people can continue to live through partnerships" with the following 10 different topics under five themes.

The applicants of Facilitator shall select the field of own expertise and devise the outline of the course that will deepen PYs thoughts by discussing a global perspective of the field in question, and how to connect what discussed into practice to solve actual local issues in Japan (Kochi Prefecture) for the local practical program to be implemented at the final port of call, and submit them with the designated form.

After devising the outline, Facilitators will have the online joint meeting with persons in charge of local practical programs as described in section 4. Facilitators will have meetings, share their perceptions with local persons in charge, and elaborate the structure of discussion activities.

- (*1) Facilitators Meeting will include an overview of the program, its objectives, and the relevance between Course Discussions and local practical program (approx. 4 hours, starting at noon (JST) (tentative)).
- (*2) Joint meeting of facilitators and persons in charge of local practical program will be held. The purpose of the meeting is to exchange opinions with the persons in charge of the local practical program in Kochi on the detailed plan and operation of the program so that Facilitators can understand the contents of the local practical program and revise the Course Discussion plan necessary for smooth facilitation.
- (*3) Discussion seminar as a preparatory session for JPYs will be held for two days (approx. 2 hours per day / tentative schedule: 18:30 on Aug. 31 & 9:00 on Sept. 2 (JST) / finalized date and time will be announced at the Facilitators Meeting).
- (*4) Due to the time difference, online program will be divided into two regions and held on Saturdays and Sundays. Saturday and Sunday will have the same content. (Duration of the session will be approx. 3 hours, and will be held on Saturday from 17:00 and Sunday from 8:00 (JST).)
- (*5) PYs who could not interact in online discussion, etc. due to the time difference will be able to freely participate and interact on this application, which is available 24 hours. Discussion group activities can also be held on this application. This application continues to be available during face-to-face exchange. Although interaction using this application is voluntary, we are considering holding some official events (date and time to be determined) to promote interaction and usage of this application by PYs.

5. Roles of Facilitators

Facilitators are expected to coordinate and manage the assigned discussion group of multinational PYs. Facilitators shall provide PYs with pre-assignment and guidance regarding the theme to carry out the Course Discussion, coordinate the course contents to promote collaboration between the Course Discussion and local practical program, lead the group during institutional visit and exchange activities with local youth in Japan, support PYs with the activities related to the discussion, and give guidance and advice to PYs so that PYs can leverage the achievements for post-program activities.
